Collection summary: The Red Kettle was a mainstream regional Irish theatre company that operated in Waterford 1985 to 2014.

Collection description: On the 26th August 2014, SETU Libraries (then WIT Libraries) became custodians of the Red Kettle Theatre Company archives on behalf of the Institute and Waterford City and County Council Archives. Prior to this agreement the archive had been privately deposited at Central Hall, Waterford where it was kept in a storeroom.

The archive of the company comprises of 174 box files spanning 78 productions containing framed pictures, posters, boxes and box files relating to productions performed by the Theatre.

Commencing with its first production 'the Gods are Angry Miss Kerr' in 1985 and most recently being "Beyond the Brooklyn Sky" in 2013.

Status: Work has begun on removing confidential information from the collection in compliance with Data Protection and copyright, these materials have been sealed under the 100 years compliance until 2114.

This collection has not been catalogued and preparation work is continuing on the inventory of this collection.
